1. Post-paid Accounts

- 1.1 All voice and data usage not set out shall be the same as the Standard Price List mentioned in the Mobile Business Plans.
- 1.2 The Customer may have multiple connections on the same Postpaid account. All connections will have the same Bill Cycle.

2. Plans

- 2.1 Each End User connection will have a monthly subscription Plan as per the IOT Shared Data Pool charges below.
- 2.2 Plans will be renewed for all End User connections on the Bill Cycle date which are on the 1st or 15th of the each month in advance.
- 2.3 Plans will be valid until the end of each Bill Cycle. Any unused value will be forfeited at the end of the Bill Cycle.
- 2.4 The Customer can purchase or change the selected Postpaid Plans anytime during a Bill Cycle. The Customer will be liable for any remaining charges on the initial Plan up to the date of the change. Charges for the new Plan for the first month will be pro-rated against the next Bill Cycle. Customers deactivating or upgrading a plan during a Bill Cycle will forfeit the remaining value within the current Plan.

3. Prepaid Usage on Postpaid

- 3.1 The Customer may load Prepaid scratch cards to their Postpaid account for personal consumption. Vodafone's standard Prepaid pricing and terms and conditions apply, which can be found at www.vodafone.ga.
- 3.2 Any Prepaid scratch card value on a business line will only incur the standard credit amount and not any additional free minutes or MB included within the Prepaid scratch card.
- 3.3 Customer may choose to use Prepaid International Calling Cards ("ICC") or Prepaid Mobile Internet one-off products for personal consumption on business lines. In this case, the full value of the ICC and/or Mobile Internet product will apply.
- 3.4 The Customer may purchase Prepaid numbers under the company name.
- The Customer's Prepaid numbers use Vodafone's standard Prepaid pricing and terms and conditions, which can be found at www.vodafone.qa.

4. Mobile Broadband

- 4.1 The value of each Plan will be valid until the end of each Bill Cycle and any unused value will be forfeited at the end of the Bill Cycle.
- 4.2 Included value is for local use only.
- 4.3 Customer will be charged for Mobile Broadband plans once per Bill Cycle.

5. Roaming

- 5.1 The Customer may only use the Plan outside the State of Qatar:
 - i. upon Vodafone prior written approval
 - ii. to a maximum of thirty (30) calendar days ("Roaming Duration"); and



- iii. subject to compliance with the rules and regulations in the overseas jurisdiction in which they are being used (including roaming regulations).
- 5.2 Standard roaming charges will apply when the Plan is used outside of the State of Qatar. If Customer exceeds the Roaming Duration, then Vodafone shall have the right to suspend and/or terminate the Plan or any part of it.

7. Extras

- 7.1 Extras are value bundles that can be purchased in addition to the Customer's Postpaid Plan ("Extras").
- 7.2 All Extras mentioned in this Tariff Document are non-renewable. Activation request has to be initiated every month by the customer.
- 7.3 Customers cannot add any Extra on the same Plan more than once in any month.
- 7.4 Extras will be valid until the end of the relevant Bill Cycle and any unused value will be forfeited at that time.
- 7.5 If a Customer deactivates an Extra during a Bill Cycle, the Customer will forfeit any remaining value. All included value in Extras is for local use only. Any usage in excess of the included value will be charged at the Standard Price List for the Plan.
